#### **PRIVACY STATEMENT**

The lawful authority for collecting the information is the *Road Transport (Public Passenger Service) Act 2001*. The information may be disclosed to Commonwealth, Territory or State law enforcement agencies, transport authorities in those jurisdictions, government agencies authorised by law, the third party insurer or individuals or their agents or insurers following a motor vehicle accident.

The legislation underpinning the regulation of Taxi Services is the *Road Transport (Public Passenger Services)*Act 2001 (the Act) and the *Road Transport (Public Passenger Services)* Regulation 2002.

#### INSTRUCTIONS FOR COMPLETION

To obtain a standard taxi licence the applicant must:

- (1) Be the accredited operator of a taxi service;
- (2) Submit a passed Vehicle Inspection Report;
- (3) Submit a certificate of currency for a public vehicle insurance policy for a public passenger vehicle; and.
- (4) Pay the determined fee. Payment can be made in person when lodging the application form by credit card, cheque or money order (made out to the RTA) or on line at www.accesscanberra.act.gov.au.
- (5) The determined fees are as follows:
  - Standard Taxi Licence annual fee is \$5,000 or you can pay quarterly instalments of \$1,500. Wheelchair Accessible Taxi Licence annual fee is \$1,000 for a single WAT or \$100 for a dual WAT

On receipt of all the above and approval the applicant will be issued with a taxi licence.
