# **Explanatory Notes**

## **Late Transfer Surcharge**

If a customer fails to finalise the transfer of a vehicle within 14 days of the date of acquisition they must pay a late transfer surcharge in addition to the fees associated with transfer.

# **Duty on vehicles**

#### 1. Vehicle

The term vehicle means any vehicle (including a trailer) that is required to be registered by the Access Canberra.

# 2. Purchase Price

Purchase price means the consideration given to purchase or acquire the motor vehicle and includes the value of any trade-in given as part of that consideration.

# 3. Representative Operator

The individual nominated as the contact person for the service of notices relating to the vehicle is taken to be the responsible person for the vehicle for any infringement notice offence involving the vehicle.

## 4. Duty

Duty must be paid at the time of registration, unless you are entitled to a Duty Exemption.

# 5. Calculation of Duty Payable on the Registration of a Motor Vehicle

To view information on how motor vehicle duty is calculated please refer to act.gov.au/duty. The market value or purchase price must include GST, trade-in allowance, fleet discounts, accessories, any additions to the vehicle and equipment attached to the cab chassis e.g. tipper body or tray.

# 6. Duty Exemption

Exemption from duty in respect of the registration of a motor vehicle is available to:

- (a) Certain Disabled Persons
- (b) Charitable Organisations
- (c) Foreign Countries
- (d) Hospitals and Schools
- (e) International Organisations and Diplomats
- (f) Registered Workplace Relations Organisations
- (g) Relationship Court Orders and Agreements
- (h) Repossessed Motor Vehicles
- (i) Successors of Deceased Persons.

Exemption from Duty may be obtained from Aaccess Canberra.

## Motor Accident Injuries (MAI) insurance providers

MAI providers cannot be changed when transferring registration.
