INFORMATION GUIDE

This self-represented party pack should only be used if the ID categories cannot be met in pack 1. See here for the Self-Represented Party Pack Categories 1-4 and 6(a) and 6(b).

The documents listed in Category 6(a) are to be used where possible to identify a person who is not an Australian citizen or resident. If these documents are not available, the documents listed in Category 6(b) are to be used.

Where the requirements of Categories 1-4 cannot be met, Category 5(a) may be used; and Category 5(a) cannot be met; Category 5(b) may be used.

If you cannot comply with the minimum identity document requirements as specified in Category 1-4, you will need to rely on someone who has known you for at least 12 months, who does have the required evidence. They then will make a declaration in regards your identity.

The Identifier Declaration should be completed by an adult who has known the person being identified for more than 12 months and is not a relative or is not a party to the instrument.

VERIFICATION OF AUTHORITY DOCUMENT CATEGORIES

The following are examples of documents that may be used to verify a person's authority to enter into a Conveyancing Transaction:
